Sub: Intimation of revision of Tariff for the users of our Coal Terminal at Kamarajar Port.

Respected Madam,

As per Licence agreement for Coal Terminal, we hereby inform you that the revised tariff for the users of our Coal Terminal Facilities with effect from **01.04.2024**, is as set below:

However, the below mentioned revision of tariff shall be without prejudice to any pending proceedings.

a) Stevedoring and handling charges

- i) Cargo handling charges including Loading on to Trucks: Rs.330/-Per MT
- ii) Cargo handling charges including Loading on to Wagons:
  To promote/incentivise the cargo movement through railway mode, effective utilization of
  Terminal railway infrastructure and considering environment benefits, the following slab wise
  cargo handling charges for railway cargo (wagon loading) are proposed:

c) Berth Hire - Rate per Gross Tonnage (GT) per Hour or part thereof:

Coastal Vessel

: Rs. 0.90 Per GT per hour

Foreign Vessel

: USD 0.0175 per GT per hour

The vessel should be ready for sailing in all respects within 2 hours of completion of cargo work. A vessel which is not ready to sail after 2 hours of completion of cargo work is liable to pay additional berth hire charges. The duration for which additional berth hire is to be charged will be calculated from the time of expiry of 2 hours from the time of completion of cargo work till the time the vessel vacates the berth.

The additional berth hire charges shall be in addition to normal berth hire charges and is Payable as follows:

- i) For the first 12 hours or part thereof equivalent to berth hire charges
- ii) Above 12 hours or part thereof at 2 times the rate of berth hire charges

For a vessel which is ready to sail in all respect but could not sail due to port operational requirements, berth hire charges will cease after 2 hours from the time of completion of cargo work.

- d) Watering charges: Watering charges will be as per customers' requirements and will differ from ship to ship and cargo type.
- e) Statutory dues, Goods & Service Tax & other levies: Extra as applicable from time to time.

We request you to publish the above tariff on the KPL website. Looking forward for continuous support and mutual co-operation.
