CONCESSION IN VESSEL RELATED CHARGES FOR THE VESSELS CALLING AT CONTAINER TERMINAL AT KPL.

KPL is pleased to inform to the Trade that, the existing Concession in Vessel related charges for the vessels calling at Container Terminal at KPL implemented vide Trade Notice No. 4/2020 dated 01.04.2020 is hereby extended till 31.03.2022.

The details of Concession in Vessel related charges for Container vessels are given below.

1. Concession in Vessel related charges for Container vessels:

The concession in Vessel related charges from the Scale of Rates for Container vessels are given below.

- i.15% Concession in VRC for all Coastal Container vessels from 01.04.2021 to 31.03.2022.
- ii. Upfront Concession in VRC to EXIM Container vessels from 01.04.2021 to 31.03.2022 as tabulated below.

3. Loyalty Reward:

In addition to the above upfront Concessions, additional benefit to those services that are loval to KPL is offered. The Container vessel services which make 30 to 49 calls from 01.04.2021 to 31.03.2022 shall be eligible for a loyalty discount @ 2% of the total VRC limited to Port Dues & Pilotage charges paid by them during the period specified (after discount) and shall be paid as Loyalty Reward at the end of the year. Further, for those services which make 50 or more calls from 01.04.2021 to 31.03.2022, 5% of the total VRC limited to Port Dues & Pilotage charges paid during the period specified (after discount) shall be given as Loyalty Reward at the end of the year. For calculation of the additional Loyalty Reward, the voyages done by the services from 01.04.2021 to 31.03.2022 shall be taken into account.

The Trade Associations are requested to bring the contents of Trade Notice to the attention to their members of the trade and everyone concerned.
