AMENDMENT IN THE SCALE OF RATES ON VESSEL RELATED CHARGES I.E. PORT DUES & PILOTAGE CHARGES FOR CONTAINER VESSELS HANDLED AT KPL & CONCESSIONS ON VESSEL RELATED CHARGES FOR THE VESSELS CALLING AT CONTAINER TERMINAL AT KPL

KPL is pleased to inform to the Trade that, the Competent Authority has accorded for an amendment in the Scale of Rates on Vessel related charges limited to Port Dues & Pilotage charges for Container vessels handled at KPL and for concessions on Vessel related charges for the vessels calling at Container Terminal at KPL. The validity period for concessions on Vessel related charges is from 04.06.2019 to 31.03.2020.

The details of Amendment in the Scale of Rates and the concessions on Vessel related charges for Container vessels are given below.

1. Amended Scale of Rates for Container vessels:

The Scale of Rates of KPL on Vessel related charges limited to Port Dues and Pilotage charges for Container vessels handled at KPL is given below. The date of effect of this amendment is from **04.06.2019**.

2. Concessions on Vessel related charges for Container vessels:

i.15% concession in VRC for all Coastal Container vessels from 04.06.2019 to 31.03.2020.

ii.Upfront concession in VRC to EXIM container vessels from 04.06.2019 to 31.03.2020 as tabulated below.

3. Loyalty Reward:

In addition to the above upfront concessions, additional benefit to those services that are loyal to KPL is offered. The container vessel services which make 30 to 49 calls from 04.06.2019 to 31.03.2020 shall be eligible for a loyalty discount @ 2% of the total VRC limited to Port Dues & Pilotage charges paid by them during the period specified (after discount) and shall be paid as Loyalty Reward at the end of the year. Further, for those services which make 50 or more calls from 04.06.2019 to 31.03.2020, 5% of the total VRC limited to Port Dues & Pilotage charges paid during the period specified (after discount) shall be given as Loyalty Reward at the end of the year. For calculation of the additional Loyalty Reward, the voyages done by the services from 04.06.2019 to 31.03.2020 shall be taken into account.

The Trade is hereby requested to widely communicate the contents of the Trade Notice among the trade members and everyone concerned.
