ADOPTING THE PREVAILING CONCESSION OFFERED IN VESSEL RELATED CHARGES FOR RORO VESSELS CALLING AT KPL'S GENERAL CARGO BERTH-II.

KPL is pleased to inform to the Trade that, in order to facilitate the Automobile stakeholders requirements, KPL completed the construction of General Cargo Berth-II with dedicated Car parking yard and Dredging activities. The General Cargo Berth-II was commissioned on 02.01.2024 by the Hon'ble Prime Minister. On 31.03.2024, the newly constructed General Cargo Berth-II was successfully put into operations.

Consequently, the following Concession offered in Vessel related charges i.e. Port Dues, Pilotage charges and Berth hire charges for RoRo vessels (Pure Car Carrier/Pure Car and Truck Carrier/RoRo Container) calling at KPL's General Cargo Berth, implemented vide Trade Notice No. 4/2023 dated 30.06.2023 for one year period from 01.07.2023 to 30.06.2024 is hereby adopted for RoRo vessels calling at General Cargo Berth-II till 30.06.2024.

The details of Concession in Vessel related charges are given below.

2	21 to 30 calls	20% of SoR	80% of SoR
3	31 to 40 calls	25% of SoR	75% of SoR
4	41 to 50 calls	30% of SoR	70% of SoR
5	51st call and above	35% of SoR	65% of SoR
