Implementation of online submission of Payment Transaction Details, Import Cargo Manifest (IGM) & Export Cargo Manifest (EGM) in Business Interface Portal of KPL.

Payment Transaction Details:

The Trade is hereby informed that, KPL has implemented "Payment Transaction Details" in Business Interface Portal (BIP) of KPL in order to digitalize the submission of Payment Transaction details of payments made outside NLP-Marine i.e., through RTGS/NEFT, etc., to Port pertaining to Vessel Related Charges (VRC) & Cargo Related Charges (CRC) under One Nation One Port Documentation process (ONOP) documentation as per the directions of Ministry of Ports, Shipping and Waterways.

In general, all Port Users are advised to utilize the Sagar Setu / NLP-Marine Portal for making payments to Port. In the event of any exceptional circumstance, the Port Users make payment outside NLP-Marine i.e. through RTGS/NEFT/IMAP, etc. The Port Users are communicating these payment details through e-mail. Henceforth, all Port Users are requested to submit the "Payment Transaction Details" in the Business Interface Portal (BIP) of KPL. The email submissions of payment transaction details will no longer be accepted by KPL.

In this regard, Vessel Handling Agents / Cargo Handling Agents are requested to register your agency in Business Interface Portal of KPL for utilizing the "Payment Transaction Details" option in BIP in order to facilitate the process for Port & Cargo clearances at KPL.
