AMENDMENT OF PORT PERMIT CHARGES AND REVISION OF MANDATORY DOCUMENTS REQUIRED FOR OBTAINING PORT PERMIT PASSES THROUGH NEW PASS ISSUANCE SYSTEM AT KPL – CORRIGENDUM - I

The Trade is hereby issued the corrigendum to the Trade Notice issued on 23.07.2025 regarding “*Amendment has been made in Port Permit charges for Individual & Vehicle Permit passes (new/renewal) and revision of mandatory documents required for obtaining Port permit passes through New Pass Issuance System at KPL.*”

1. The Port permit charges provided for Sl. No. 2 - Vehicles is for all the Vehicles (including Two Wheelers, Commercial & Non-Commercial Vehicles) except Sl. No. - 3 - Heavy Vehicles - Cargo Handling Equipment & Construction Equipment.
2. The Mandatory document to be uploaded for Sl. No. 1 & 2 (Individual & Driver): Police Verification Certificate for **long term pass (Monthly and above passes)**. Should be issued within the last six months at the time of applying passes is revised as Police Verification Certificate for **long term pass (Yearly passes)**. Should be issued within the last six months at the time of applying passes.

In case of Permanent employees of BoT / Captive users, they shall submit a undertaking letter for the permanent employees yearly once instead of Police Verification Certificate for obtaining Port permit passes. The format is attached.

3. The Mandatory document to be uploaded for Sl. No. 5 - Heavy vehicles – Cargo Handling Equipment is revised as below:
