CONCESSION IN VESSEL RELATED CHARGES I.E. PORT DUES AND PILOTAGE CHARGES FOR DRY BULK VESSELS CALLING AT MULTI CARGO TERMINAL AT KPL.

KPL is pleased to inform the Trade that, the Concession offered in Vessel Related Charges i.e. Port Dues and Pilotage charges for Cape Size vessels calling at Multi Cargo Terminal at KPL implemented vide Trade Notice No. 6/2025 dated 16.06.2025 is hereby modified and extended to all Dry Bulk Vessels calling at Multi Cargo Terminal at KPL for one year period with effect from 02.02.2026 to 01.02.2027.

The details of Concession in Vessel Related Charges are given below.

The Concession in Vessel Related Charges on Scale of Rates (SoR) shall be offered to those foreign trade vessels which handle Dry Bulk cargoes at Multi Cargo Terminal subject to fulfilling the following conditions:-

Eligible Parcel size	Concession in Vessel Related Charges i.e. Port Dues and Pilotage charges (Foreign Trade) per vessel call
50,000 MT to 1,00,000 MT	40% of SoR
1,00,001 MT and above	50% of SoR

1. The Concession scheme shall be availed by the Customers of Multi Cargo Terminal, upon submission of Bank Guarantee towards the Minimum Guaranteed Tonnage of 0.50 Million Tonnes of Dry Bulk Cargoes during the Concession period.
2. Achievement of Minimum Guaranteed Tonnage of 0.50 Million Tonnes of Dry Bulk Cargoes by a Customer during the Concession period shall be reckoned based on the certification by the Multi Cargo Terminal.
3. The Eligibility for availing the Concession is cargo handled at Multi Cargo Terminal based on the Customs documents (i.e. Import General Manifest (IGM) & Bill of Entry for Import and Shipping Bill for Export).
4. The Concession can be availed on each eligible vessel after completion of cargo based on the certification of Traffic department.
5. The Concession shall be extended to the Vessel Agents/Shipping line those who are remitting Vessel related charges to KPL.

The modified Concession in Vessel related charges for Dry Buk vessels calling at Multi Cargo Terminal supersedes the Trade Notice No. 6/2025 dated 16.06.2025.

The Trade Associations are requested to bring the contents of Trade Notice to the attention of Trade members and everyone concerned.
