TRADE NOTICE NO: 12/2020 DATED: 27.11.2020

REBATE IN VESSEL RELATED CHARGES (VRC) FOR VESSELS CARRYING EXIM TRANSSHIPMENT CONTAINERS AT KPL.

Kamarajar Port is pleased to extend the following rebate structure on Vessel Related Charges for a period of three years from 27.11.2020 to 26.11.2023 for Mainline Container Vessel Services and Feeder Vessel calls carrying EXIM Transshipment Containers and for a period of one year from 27.11.2020 to 26.11.2021 for Mainline Container Vessel Calls (Ad hoc) carrying EXIM Transshipment Containers.

Rebate in Vessel Related Charges on Scale of Rates (SoR) shall be offered to those foreign going vessels which handle EXIM Transshipment containers at KPL, subject to the following conditions:-

1. For Mainline Services calls:

QC – No. of Vessel Calls for a Quarter of 13 weeks	Rebate to Eligible Calls if QC is achieved (%)	Rebate to Eligible Calls if QC is not achieved (%)
Minimum of 12 Eligible Calls	85	50

2. For Mainline Ad hoc calls:

QC – No. of Vessel Calls	Rebate to Eligible Calls if QC is achieved (%)
Minimum of 2 Eligible Calls in a period of 30 days or 5 Eligible Calls in a Quarter of 13 weeks	50
Minimum of 12 Eligible Calls in a Quarter of 13 weeks	70

For 1 & 2:

I: Eligible call means

- (a) In that call a minimum of 1,000 TEU's of EXIM Transshipment containers are handled and the EXIM Transshipment containers TEU's handled is at least 50% of the total containers TEU's handled at KPL in that call and
- (b) The Mainline vessel making that call is having more than 40,000 GRT.

II: Mainline Container Vessel Services means as Vessel services with international ports of call in the continents of Americas, Europe, Africa, Australia and any port in China, Korea or Japan.

3. For Feeder Vessel calls:


QC – No. of Vessel Calls	Rebate to Eligible Calls if QC is achieved (%)
Minimum of 12 Eligible Calls in a Quarter of 13 weeks	50

For 3:

Eligible call means, in that call a minimum of 500 TEU's of EXIM transshipment containers are handled.

- 4. The Trade Notice No. 9/2020 dated 24.10.2020 issued earlier is cancelled.
- 5. The rebates for foreign container services / vessels will be applicable only if the services or the vessels do not avail any coastal concession under any scheme, and pay VRC applicable for foreign run vessels.
- 6. The rebates provided under this Notice cannot be clubbed with any other rebates / concessions.

The Trade Associations are requested to bring the contents of the Trade Notice to the attention of their members, trade and everyone concerned.
