CONCESSION IN VESSEL RELATED CHARGES (VRC) FOR VESSELS CARRYING LADEN EXIM TRANSSHIPMENT CONTAINERS AT KPL.

Kamarajar Port is pleased to extend a Concession scheme in Vessel Related Charges for vessels carrying Laden EXIM Transshipment Containers with effect from 01.11.2020.

Concession of 50% in vessel related charges as per SoR shall be offered to those foreign going vessels which handles laden EXIM transshipment containers at KPL, subject to the following conditions:-

1. The Service shall make a minimum of 10 voyages in KPL per quarter.
2. The service shall handle a minimum of 1,500 TEU's laden EXIM transshipment containers at KPL per quarter.

If the above conditions are achieved, the concession will be extended at the end of each quarter.

Further, if in any quarter, 1,500 TEU's laden EXIM transshipment containers are not handled but cumulatively 6,000 TEU's of laden EXIM transshipment boxes are handled in that year, then the concession will be extended for that quarter also, provided a minimum of 10 voyages are achieved in that quarter by the service.

In addition to the above, if more than 48 voyages in a year is achieved, a further discount of 2% of the VRC already collected for the year shall be granted as loyalty discount.

The concession will be extended only on an agreement entered with the Port for a minimum period of two years. Other concessions prevailing for the foreign going vessels cannot be clubbed with the above VRC concession.

The Trade Associations are requested to bring the contents of the Trade Notice to the attention of their members, trade and everyone concerned.
